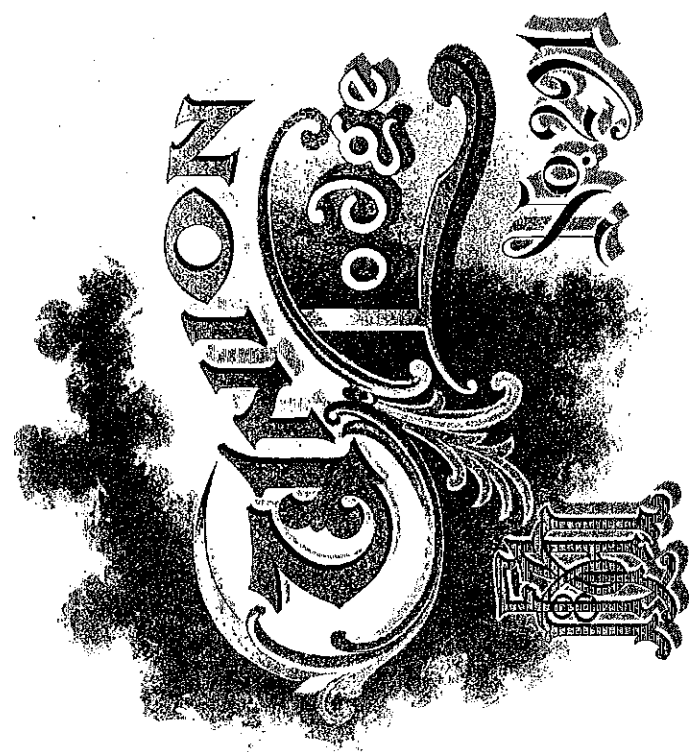

REVISION OF THE BY-LAWS OF UNION LODGE No. 291

The following amendments to the BY-LAWS which were again presented at the last stated meeting and laid over for a month will be separately acted upon for adoption:

RESOLVED: That Article VI Section 1 be amended by striking out the words "Twenty Dollars" in the second line and inserting in lieu thereof the words "Twenty-Five," so that the section as amended shall read "The Dues of Each member shall be TWENTY-FIVE DOLLARS per annum, except when otherwise provided by these BY-LAWS".

RESOLVED: That Article III Section 3 be amended by striking out the words "Eight Hundred and Fifty Dollars" per annum and be exempt from dues, and inserting in lieu thereof the words "ONE THOUSAND DOLLARS", so that the section as amended shall read: "For his services he shall receive ONE THOUSAND DOLLARS per annum and be exempt from dues.

RESOLVED: That Article III, Section 2 be amended by striking out the words "Fifty Dollars" per annum, and inserting in lieu thereof the words "One Hundred Dollars" per annum.
