AMENDMENTS TO THE BY-LAWS

Action will be had upon the following proposed amendments to the By-Laws:

Resolved, That Article VII, Section 1, be amended by striking out the words "one hundred" in the third line and inserting in lieu thereof the words "three hundred," so that the same shall read: "Article VII, Section 1—Any member of the Lodge who shall pay, over and above all arrearages of dues, the sum of three hundred dollars, shall be constituted a Life Member and shall be exempt from all dues."

Resolved, That Sections 2, 3, and 4 of Article VII be stricken out and that the present Sections 5, 6, and 7 be made Sections 2, 3, and 4 respectively.
